Privacy Policy

Multicultural children Center respects your privacy as we care for your child, with care and caution. Safety and security are integral in everything we do, which is why we protect your family in person as well as your privacy online. Also, we support every family's situation fairly and equally.

This Privacy Policy informs you of our rules regarding the collection, how we use that information, and how it applies when you access or use our website, mobile applications, and services. Multicultural Children Center collect personal data for billing, parent/guardian communication and optimization of your service. Personal data it **is not sold to any third parties**. Definitions

- Service: means the www.multiculturalchildrencenter.com website, and/or <https://info.mybrightwheel.com/>
- Personal Data: means data about a living individual who can be identified from those data (or from those and other information either in our possession or likely to come into our possession).
- Usage Data: is data collected automatically either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).
- Cookies: are small files stored on your device (computer or mobile device).

Information Collection and Use:

We collect several different types of information for various purposes to provide and improve our Service to you.

Types of Data Collected

Personal Data

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally, identifiable information may include, but is not limited to:

- Email address
- First name and last name
- Phone number

- Cookies and Usage Data

Usage Data

This Usage Data may include information such as your computer's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

When you access the Service with a mobile device, this Usage Data may include information such as the type of mobile device you use, your mobile device unique ID, the *MChC address* of your mobile device, your mobile operating system, the type of mobile Internet browser you use, unique device identifiers and other diagnostic data.

Collected Data

MULTICULTURAL CHILDREN CENTER uses the collected data for various purposes:

- To provide and maintain our Service
- To notify you about changes to our Service

- To provide customer support
- To gather analysis or valuable information so that we can improve our Service
- To monitor the usage of our Service
- To provide you with news, special programs and general information about other Enrichment-Recreational services, goods and events which we offer that are similar to those that you have already enrolled.

Tracking & Cookies Data

We use cookies and similar tracking technologies to track the activity on our Service and we hold certain information. Cookies are files with a small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Other tracking technologies are also used such as beacons, tags and scripts to collect and track information and to improve and analyses our Service.
